- 2 PILOT Request by Dole Refrigeration for Purchase of Laser.

Dole is requesting a PILOT for an investment of \$845,000 on a laser, similar to the laser purchased in 2020. The PILOT offer is 50% Year One, 75% Year Two and 100% Year Three and thereafter. Project savings to Dole will be \$7,397 and Projected Revenues to County/City will be \$19,243.50. Projected employment will be 10 jobs over 5 years.
