#### Item 1. Announcements:

- b. Mayor Bingham announced the City's receipt of 2 grant awards totaling one million dollars. \$500K HOME Grant to assist low income homeowners with home repairs or replacements and \$500k CDGG-CV Grant to assist a day care facility with an expansion.

Winford Wentzel - 1216 Long Distance Rd., Lewisburg: reiterated same comments as expressed in the public hearing concerning annexations. Susan Tonsetic - 460 Moonlight Trail: against so many annexations and the problems that come with them, infrastructure, safety, etc. Nathan Collier - 1725 Nashville Hwy - gave statistics and recommendations relating to emergency personnel that would be required for all the additional roof tops. Denny Tucker - 1731 Fayetteville Hwy, expressed concerns about additional subdivisions and infrastructure to support these, noting the water pressure in his area is already a problem. Sheila Holt McMillen - 1880 Holly Grove Rd., Lewisburg: reiterated same comments as expressed in the public hearing concerning annexations. Kenny Hopwood - 1409 Holly Grove Rd., Lewisburg: reiterated same comments as expressed in the public hearing concerning annexations. Craig Blackwell -4740 Smiley Rd., Chapel Hill: reiterated same comments as expressed in the public hearing concerning annexations.
