This is a 2-hour rental and includes the services of four (4) lifeguards. \$35 for each additional twenty-five (25) swimmers will be charged. Each additional twenty-five (25) swimmers will require the services of one (1) additional lifeguard.						
8.	. A DEPOSIT OF 50% OF TOTAL is DUE 14 DAYS AFTER BOOKING in order to confirm your date or it will be given away if another call comes in. The balance is DUE 7 DAYS PRIOR TO THE EVENT.
