Rules & Regulations for use of the OUTDOOR POOL

1. The applicant shall be responsible for any damage to equipment or property. If, after any activity additional janitorial maintenance is required, other than the normal cleaning process (*see check list*), the applicant may be charged accordingly.
2. A minimum of four (4) Certified Lifeguards must be on duty and present at all times for access into gated area.
3. Children under the age of ten (10) and persons unable to swim must be supervised by responsible adults at all times.
4. **The posted pool rules must be followed at all times during the course of the activity. The group must also follow the directions of the certified lifeguards on duty during the course of the activity.**
5. The Aquatics Director may reserve the right to cancel the activities at any time if it seems necessary.
6. No alcoholic beverages, **no smoking**, and **no glass** allowed in the pool area. Persons under the influence of alcohol or drugs will not be allowed on the premises at any time.
7. Fee for renting of the pool is \$175 for fifty (50) swimmers or less. This is a 2-hour rental and includes the services of four (4) lifeguards. \$35 for each additional twenty-five (25) swimmers will be charged. Each additional twenty-five (25) swimmers will require the services of one (1) additional lifeguard.
8. **A DEPOSIT OF 50% OF TOTAL is DUE 14 DAYS AFTER BOOKING in order to confirm your date or it will be given away if another call comes in. The balance is DUE 7 DAYS PRIOR TO THE EVENT.**
9. **In the event of a rainout a raincheck will be issued for another date that calendar year.**

Rules & Regulations for use of the INDOOR POOL

1. The applicant shall be responsible for any damage to equipment or property. If, after any activity additional janitorial maintenance is required, other than the normal cleaning process (see check list), the applicant may be charged accordingly.
2. A minimum of two (2) Certified Lifeguards must be on duty and present at all times for access into the pool.
3. Children under the age of ten (10) and persons unable to swim must be supervised by responsible adults at all times.
4. **The posted pool rules must be followed at all times during the course of the activity. The group must also follow the directions of the certified lifeguards on duty during the course of the activity.**
5. The Director may reserve the right to cancel the activities at any time if it seems necessary.
6. **No food or drink allowed in the pool area.** Persons under the influence of alcohol or drugs will not be allowed on the premises at any time.
7. Fee for renting of the pool is \$135 for fifty (50) swimmers or less. \$35 for each additional twenty-five (25) swimmers will be charged. Each additional twenty-five (25) swimmers will require the services of one (1) additional lifeguard.
8. **The pool party includes: use of the small meeting room located in the sports complex and private pool use for your group. The rental time is for a TOTAL TIME OF 2 HOURS.**
9. **A DEPOSIT OF 50% OF TOTAL is DUE 14 DAYS AFTER BOOKING in order to confirm your date or it will be given away if another call comes in. The balance is DUE 7 DAYS PRIOR TO THE EVENT.**
