Discussion ensued regarding the City's current social media policy and a recent post made on Facebook by Parks & Recreation Director Cary Whitesell (note post was made on her personal page and not on a City site). Post was related to a recent vote by Council for cost -of-living increases for City employees. After discussion Councilman Burns asked City Attorney Hutto to provide written answers to the following questions:

- 1. Did the post violate any city policies?
- 2. Was the post made during Mrs. Whitesell's working hours?
- 3. Was a City device used to make the post?

Councilman Bradford added that he would like to reiterate that per the current policy under the section of Comment Policy, number 6 that if an employee is responding to a comment in their official capacity as a City employee, they should also list their name and title to be clear of who is responding to the post.

Councilman Burns brought up an additional conduct issue stating it involved the aforementioned employee asking if discussion was need or if it had been addressed. City Manager Haislip confirmed that both mentioned concerns had been addressed.

i. Discuss plan for filling City Recorder/HR Representative position due to resignation of City Recorder Pam Davis. (Councilman Bradford)

Discussion ensued.

Directions were given to the City Recorder to draft an advertisement for her position and publish accordingly. A special called meeting with Council will be held on Friday, July 14th, at 10:00 a.m. to discuss plan moving forward.
