Discussion, Review, and Take Action on the following items:

New Business:

- a. **Discussion (zoom call with Municipal Technical Advisory Service-MTAS consultant Patrick Marsh) and possible action on revisiting City Manager candidates or open recruiting process/interviewing with consideration of salary.**

Councilman Burns made a motion to hire Billy Spivey as the same salary \$110,000 we offered to the other gentleman, subject to background check. Councilman Thomas seconded the motion.

**Motion passes 4-1**

Mayor called Mr. Billy Spivey to offer him the City Manager position pending the successful background check.

**b. Interview and consider Interim City Treasurer Debbie Montgomery for City Treasurer position and determine salary.**

Interview questions were presented by Council Burns with Ms. Montgomery in response to each question.

Discussion ensued about salary for City Treasurer positions. Ms. Montgomery requested a \$95,000 annual salary for the City Treasurer position.

Councilman Michael made the motion to hire Debbie Montgomery as full-time City Treasurer at a salary at \$95,000. Councilman Thomas seconded the motion.

**Motion passes 5-0**
